FREQUENTLY ASKED QUESTIONS

1. Who may participate?

Any bona fide pupil, teacher and/or administration staff member of any school (including pre-Primary schools).

2. When will cover be in force?

The cover is for any emergency medical treatment administered in response to an episode of illness or injury that of necessity requires immediate medical attention: On school premises; Outside the school whilst participating in any sporting activity or other extra-mural activity organised and supervised by the school; Whilst travelling to or from school or any other sporting or extra-mural activity by a reasonably direct route; at after care centres registered and recognised by local authorities;

3. What is the Service being offered?

The service being offered is known as **Netcare 911 Scholar**.

It provides the participants/members with a national emergency medical service, which can respond in a rational and effective manner, to members facing serious medical emergencies. This includes a medical emergency evacuation service. These include:

4. Additional benefits

Medical standby at high level games will be provided if required (one ambulance for eight hours maximum), one standby per school per annum. At least two weeks notice is required before the event.

5. What are the costs?

Per person per annum – R40.00.
